

DECREE

In accordance with canons 50, 120 §1, 121, and 515 of the Code of Canon Law and after having consulted the Presbyteral Council and members of the faithful of the concerned parishes, I hereby decree that Saint Joseph Parish in Tiff, Missouri, is amalgamated into Saint Joachim Parish in Old Mines, Missouri.

I further decree that the territory formerly belonging to Saint Joseph Parish is subsumed into Saint Joachim Parish. Saint Joachim Parish obtains the temporal goods, patrimonial rights, and obligations which formerly belonged to Saint Joseph Parish (canon 121). While Saint Joseph Church remains a sacred edifice to which the faithful have the right of entry (canon 1214), Saint Joachim Church is the Parish Church. I direct that all ecclesiastical records of Saint Joseph Parish be forwarded to the Archives of the Curia of the Archdiocese of Saint Louis.

The following are the reasons in summary form for Saint Joseph Parish being amalgamated into Saint Joachim Parish (canon 51).

- 1. Saint Joseph Parish has only 34 Catholic households, 8 fewer than in 2013.
- 2. There are few adult Catholics served by Saint Joseph Parish under age 50.
- 3. In 2013, 30 members of the faithful were present for the celebration of the Most Holy Eucharist on Sundays, but now there are 15 members of the faithful present.
- 4. The parish has averaged 0 infant baptisms and 0 funerals annually for the past five years.

This Decree is effective August 1, 2023. Its official notification is its publication on the website of the Archdiocese of Saint Louis on May 28, 2023.

I direct that the Pastor of Saint Joseph Parish and the Pastor of Saint Joachim Parish announce at all Masses on the weekend of May 27-28, 2023, that this Decree has been published on the website of the Archdiocese of Saint Louis (allthingsnew.archstl.org). I ask the Pastor and the faithful of Saint Joachim Parish to make every effort to welcome warmly the members of the former Saint Joseph Parish.

Any member of Saint Joseph Parish who claims to have been aggrieved by this Decree has the right to seek its revocation or emendation (canon 1734). This request must be made in writing and postmarked no later than June 12, 2023, to the Most Reverend Archbishop of Saint Louis, Cardinal Rigali Center, 20 Archbishop May Drive, Saint Louis, Missouri 63119.

Anything to the contrary notwithstanding.
